DISCLOSURES AND EXPECTATIONS

Loan Details

- Each owner with 20% or more ownership is required to sign a personal guaranty. If owner's are married, their spouse must also sign the guaranty.
- An origination fee of 1% of the loan amount will be subtracted from your total loan funding, no fees will be due at closing.
- At closing, all owners must sign a Personal Guarantee, Promissory Note, Commitment Letter and W9.
- Monthly payments will be pulled from your business bank account *automatically* on the 10th day of each month via ACH. The account information you submit through the ACH form will be subject to monthly payment pulls.
- There is a \$25 NSF fee for each payment that is not completed via ACH pull due to non-sufficient funds.
- There is no pre-payment penalty for the Semillas micro-loan.

Semillas Awardee Support

- The lending team will schedule annual site visits and check in meetings during the life of the loan to offer business coaching and support.
- Awardees are expected to communicate any repayment challenges with the lending team to create repayment solutions and prevent any fees for non-payment.
- Awardees will receive updates about new programs and offerings for small business owners through the Groundswell Capital Monthly Newsletter
- Awardees will receive monthly text reminders about upcoming payments due
- Applicants will complete the application in full and be present to attend all meetings with the Lender to be considered for funding.
- Applicants must adhere to eligible industry and eligible loan use requirements (see website for qualifications).
